#### **REGULATIONS**

### of the World Adult, Junior, Youth, Cadet, Beach SAMBO Championships

### 1. Management of the competition

General management of the organization and holding of the Championships shall be the responsibility of the International SAMBO Federation (hereinafter the FIAS) together with the host country of the Championships (hereinafter the Organizing Committee).

The direct conduct of the Championships is entrusted to the Organizing Committee and the panel of referees approved by the Chairman of the FIAS Technical Commission.

### 2. Participants and conditions of the competition

The Championships program is represented by the following disciplines and categories: World Adult Championships

- Sport and Combat SAMBO (men) 58, 64, 71, 79, 88, 98, over 98 kg;
- Sport and Combat SAMBO (women) 50, 54, 59, 65, 72, 80, over 80 kg.
   World Junior Championships
- Sport and Combat SAMBO (men) 58, 64, 71, 79, 88, 98, over 98 kg;

A participant's affiliation with an age group shall be determined by the year of birth. The year of a participant's birth must be specified in the Regulations.

Athletes not younger than 18 years old are admitted to the World Championships (Adults and Beach SAMBO).

Athletes aged 18-20 years are admitted to the World Junior Championships.

Athletes aged 16-18 years are admitted to the World Youth Championships.

Athletes aged 14-16 years are admitted to the World Cadet Championships.

\* The World Cadet Championships are held every two years.

In the Championships, in each weight category, 1 athlete from the country is allowed. Each participant must have FIAS certified uniform with a backnumber on the jacket with the name and country code (list of IOC codes).

Applications for participation from the NSF must be registered in the FIAS Database. The NSF must settle all issues with FIAS (financial, disciplinary, ethical, anti-doping,

### 3. Financial conditions and insurance of participants

The cost of the FIAS license and insurance is 60 USD for each participant (athlete, coach).

The cost of accommodation with 2 meals a day – (triple room - 80 USD, double room - 100 USD; single room - 150 USD) per day for each member of the delegation.

### 4. Refereeing

Referees of the International category with a valid FIAS license, appointed by the Chairman of the FIAS Technical Commission, are allowed to officiate at the Championships.

Payment of travel expenses and salaries of referees is provided by FIAS.

The Organizing Committee provides accommodation for the referees.

### 5. Anti-Doping

Anti-Doping control is carried out by the official national Anti-Doping agency accredited by WADA. Payment for the doping control procedure is provided by the Organizing Committee.

\* At the World Cadet Championships, doping control is not provided.

### 6. Press, television, marketing and advertising

The Organizing Committee of the Competition provides all the necessary conditions for the work of press representatives in accordance with the FIAS Press Guidelines.

The FIAS shall own all broadcasting and distribution rights related to the Official FIAS Competitions. FIAS provides travel, accommodation and salary for the TV group.

The Organizing Committee of the Competition guarantees the observance of sponsorship rights to FIAS partners and sponsors, according to the FIAS Marketing Guidelines.

## **REGULATIONS** of the World Masters Championships

### 1. Management of the competition

General management of the organization and holding of the Championships shall be the responsibility of the International SAMBO Federation (hereinafter the FIAS) together with the host country of the Championships (hereinafter the Organizing Committee).

The direct conduct of the Championships is entrusted to the Organizing Committee and the panel of referees approved by the Chairman of the FIAS Technical Commission.

### 2. Participants and conditions of the competition

The Championships program is represented by the following categories:

- Sport SAMBO (men) 64, 71, 79, 88, 98, over 98 kg;
- Sport SAMBO (women) 54, 59, 65, 72, 80, over 80 kg.

Athletes older than 35 years old are admitted to the World Masters Championships.

Age groups of participants in official FIAS Masters competitions (men and women): 35-39, 40-44, 45-49, 50-54, 55-59, 60-64, over 65.

There is no limit on the number of participants from one country in the Championships. Each participant must have FIAS certified uniform with a backnumber on the jacket with the name and country code (list of IOC codes).

The NSF must settle all issues with FIAS (financial, disciplinary, ethical, etc.).

### 3. Financial conditions and insurance of participants

The cost of the FIAS license and insurance is 60 USD for each participant.

Each participant pays an entry fee of 100 USD to the NSF.

Participants are responsible for their own accommodation, meals and airport-hotel-arena-airport transfers.

### 4. Refereeing

Referees of the International category appointed by the Chairman of the FIAS Technical Commission, are allowed to officiate at the Championships.

Payment of travel expenses and salaries of referees (10 people) is provided by FIAS.

The Organizing Committee provides accommodation for the referees.

### 5. Anti-Doping

At the Championships, doping control is not provided.

### 6. Press, television, marketing and advertising

The Organizing Committee of the Competition provides all the necessary conditions for the work of press representatives in accordance with the FIAS Press Guidelines.

The FIAS shall own all broadcasting and distribution rights related to the Official FIAS Competitions.

The Organizing Committee of the Competition provides the broadcast of the Championships on the FIAS website.

The Organizing Committee of the Competition guarantees the observance of sponsorship rights to FIAS partners and sponsors, according to the FIAS Marketing Guidelines.

The NSF must settle all issues with FIAS (financial, disciplinary, ethical, anti-doping, etc.).

The Organizing Committee should guarantee the participation of 15 countries in the World Cup.

### 3. Financial conditions and insurance of participants

The cost of the FIAS license and insurance is 60 USD for each participant (athlete, coach).

The cost of accommodation with 2 meals a day – (triple room - 80 USD, double room - 100 USD; single room - 150 USD) per day for each member of the delegation.

The cost of the airport-hotel-arena-airport transfer is 20 USD for each member of the delegation.

### 4. Refereeing

Each participant must have FIAS certified uniform with a backnumber on the jacket with the name and country code (list of IOC codes).

Applications for participation from the NSF must be registered in the FIAS Database.

The cost of accommodation with 2 meals a day – (triple room - 80 USD, double room - 100 USD; single room - 150 USD) per day for each member of the delegation.

The cost of the airport-hotel-arena-airport transfer is 20 USD for each member of the delegation.

### 4. Refereeing

5 international category referees (Chief Referee, Chief Secretary, Deputy Chief Referees) with a valid FIAS license, appointed by the Chairman of the FIAS Technical Commission, are allowed to officiate at the Continental Cup. The remaining referees (10 people) are appointed by the Chairman of the CSF Technical Commission.

Payment of travel expenses and salaries of the 5 referees is provided by FIAS.

Payment of travel expenses and salaries of the 10 referees is provided by CSF.

The Organizing Committee provides accommodation for the 15 referees.

### 5. Anti-Doping

At the Continental Cup, doping control is not provided.

## REGULATIONS of the International Tournament

General management of the organization and holding of the International Tournament (hereinafter the Tournament) shall be the responsibility of the host country of the Tournament (hereinafter the Organizing Committee).

The direct conduct of the Tournament is entrusted to the Organizing Committee and the panel of referees approved by the Chairman of National SAMBO Federation Technical Commission.

### 2. Participants and conditions of the competition

The Tournament program is approved by the Organizing Committee.

Athletes not younger than 18 years old are admitted to the Tournament.

An unlimited number of athletes are allowed to participate in the Tournament in each weight category.

Each participant must have FIAS certified uniform with a backnumber on the jacket with the name and country code (list of IOC codes).

### 3. Financial conditions and insurance of participants

The cost of the entry fee for the Tournament, accommodation, transfer is approved by the Organizing Committee.

### 4. Refereeing

Refereeing at the Tournament (number of referees, qualification, payment) is provided by the Organizing Committee and the CSF.

At the end of the tournament, the Organizing Committee is obliged to send a secretary's report (list of teams, list of winners) to the FIAS email for publication of the results on the official FIAS website.

### 5. Anti-Doping

At the Tournament, doping control is not provided.

### 6. Press, television, marketing and advertising

The Organizing Committee provides all the necessary conditions for the work of press representatives in accordance with the FIAS Press Guidelines.

The Organizing Committee provides the broadcast of the Tournament on the CSF website.
