

MINUTES
of the XXXVII Congress of the International SAMBO Federation (FIAS)

Bishkek, Kyrgyzstan, November, 7th, 2025

Voting delegates representing 89 National SAMBO Federations (Attendance list in Appendix 1)

I. Opening of the XXXVII FIAS Congress

Speaker: Mr. V. Shestakov

Mr. V. Shestakov, President of FIAS welcomed the members present at the XXXVII FIAS Congress, informed that FIAS Congress takes part in a hybrid format (members are presented in the Congress Hall as well as via Zoom), mentioned that FIAS used independent platform for voting – LUMI.

II. Roll-call

Speaker: Mr. V. Shestakov, Mr. S. Gopi

Mr. V. Shestakov informed the Congress that FIAS Executive Committee appointed a Congress Registration Commission with Mr. S. Gopi as a Chairman.

Mr. S. Gopi announced that the Registration Commission had diligently verified mandates presented and had duly registered all members eligible to participate in the XXXVII FIAS Congress presented in the Congress Hall or via Zoom.

Based on the above, Mr. V. Shestakov declared that quorum for decision-making was adequate and that the XXXVII Congress of International SAMBO Federation was declared open.

III. Nomination of stewards and scrutineers

Speaker: Mr. V. Shestakov, Mr. A. Hampshire

Mr. V. Shestakov mentioned again that FIAS used LUMI platform for voting and asked representative of LUMI Mr. A. Hampshire to do a presentation of LUMI platform.

Mr. A. Hampshire did a presentation of LUMI platform.

Mr. V. Shestakov proposed to elect Ms. Kh. El-Moustaid Billah of Morocco, Mr. Tamaz Turmanidze of Georgia and Mr. Abbasali Akbari of Iran as Congress scrutineers.

Voting: 69 members voted for the Motion, 2 Against.

Resolved that the Motion be adopted.

IV. Approval of the Minutes of the FIAS Congress 2024

Speaker: Mr. V. Shestakov

Mr. V. Shestakov proposed that the Minutes of XXXVI FIAS Congress held in Astana (Kazakhstan) in 2024 (Appendix 2) shall be approved and requested the members present to vote and approve the said Minutes.

Voting: 71 members voted for the Motion, Nil against.

Resolved that the Motion be adopted.

V. Adoption of the XXXVII FIAS Congress Agenda

Speaker: Mr. V. Shestakov

Mr. V. Shestakov proposed the motion that the members present shall adopt the Agenda for the XXXVII FIAS Congress (Appendix 3) as proposed by the FIAS Executive Committee.

Voting: 75 Members Voted for the Motion, Nil against.

Resolved that the Motion be adopted.

VI. FIAS membership

Speaker: Mr. S. Gopi, Mr. V. Shestakov

Mr. S. Gopi proposed to the Congress in his capacity of Chairman of the FIAS Legal Commission to grant FIAS membership to following legal entitles:

- a) the Sambo Association of Nigeria, presided by Loveth Howell;
- b) Sambo Federation of Togo, presided by Anenou Ayité Aziandouvo;
- c) the Central African SAMBO Federation, presided by Mobilignawa Cyrille Kevin;
- d) the Sambo Union of the Federation Bosnia and Herzegovina, presided by Majo Cesko;
- e) the Sambo Association of Maldives, presided by Ms. Fatmah Shaha Hasan.

Mr. Gopi stressed on that the Türkiye Federation of Developing Sport Branches had requested for FIAS membership, but in the same time they hadn't been follow for

instructions of FIAS EC to support the letter from the current FIAS member -The Sambo Clubs federation of Türkiye- of withdrawing from FIAS membership as well as to cover all of debts for membership fees for Türkiye from 2020 to 2025 (as the same persons are in governing bodies in both organisations). In this regard Türkiye's issue was excluded from the voting.

Mr. V. Shestakov proposed to vote for the said motion (granting of FIAS membership for 5 mentioned organisations).

Voting: 76 Members Voted for the Motion, Nil against.

Resolved that the Motion be adopted.

VII. FIAS President's report

Speaker: Mr. V. Shestakov

Mr. V. Shestakov, FIAS President, spoke in length informing the members present of various aspects of SAMBO development in 2025.

Mr. V. Shestakov proposed the motion that the members present adopt the FIAS President's report (Appendix 4).

Voting: 74 Members Voted for the Motion, Nil against.

Resolved that the Motion be adopted.

VIII. FIAS Statutes

Speaker: Mr. S. Gopi, Mr. V. Shestakov

Mr. S. Gopi announced the proposals to change the FIAS Statutes and Bylaws (Appendix 5).

Mr. V. Shestakov suggested to vote for adoption of the changes to the FIAS Statutes.

Voting: 73 Members Voted for the Motion, Nil against.

Resolved that the Motion be adopted.

IX. Report of the FIAS Finance Commission

Speaker: Mr. A. Korsik, Mr. V. Shestakov

Mr. A. Korsik gave a report on the financial status of FIAS and then Mr. V. Shestakov proposed the motion that the Members present vote for FIAS Balance Sheet 2024 (Appendix 6), FIAS Audit 2024 prepared by DRP (Appendix 7), FIAS Provisional budget 2026.

Voting: 78 Members Voted for the Motion, Nil against.

Resolved that the Motion be adopted.

X. Report of the FIAS Commissions

Speaker: Mr. V. Shestakov

Mr. V. Shestakov announced a report of FIAS Commissions work during 2025 and proposed the motion that the members vote to adopt the report of the FIAS Commissions (Appendix 8).

Voting: 75 Members Voted for the Motion, Nil against.

Resolved that the Motion be adopted.

XI. FIAS Executive Committee members' elections

Speaker: Mr. V. Shestakov, Mr. R. Dimitrov

Mr. V. Shestakov informed that according to the FIAS Statute the number of the FIAS Executive Committee members is defined by the Congress and suggested to approve the number of FIAS Executive Committee members - 18.

Voting: 78 Members Voted for the Motion, Nil against.

Resolved that the Motion be adopted.

Mr. V. Shestakov informed the FIAS Congress about the requirements of FIAS Statute for FIAS Executive Committee members and stressed on the FIAS Statute's articles explaining legal status of continental presidents, the Chairman of FIAS Athletes' Commission, newly changes to FIAS Statutes regarding legal status of the FIAS Commission's for athletes with different abilities Chairman and guarantees for woman candidatures.

Mr. V. Shestakov announced the names of the candidates for the FIAS Executive Committee.

Mr. Rosen Dimitrov of Bulgaria asked a floor and explained the situation with Mariya Oryashkova nomination as due to the technical mistakes her nomination had been rejected by FIAS Executive Committee on October, 3, 2025 and asked a Congress to include Ms. Oryashkova to the list of candidates to the FIAS Executive Committee.

Mr. V. Shestakov suggested to vote for the inclusion of Ms. Oryashkova to the list of candidates to the FIAS Executive Committee.

Voting: 74 Members Voted for the Motion, Nil against.

Resolved that the Motion be adopted.

Mr. V. Shestakov proposed to choose firstly 3 female representatives from 6 female candidatures.

Mr. V. Shestakov proposed the motion for Mr. S. Eliseev to be elected as FIAS 1st Vice-president.

Voting: 75 Members Voted for the Motion, 3 against.

Resolved that the Motion be adopted.

XII. Items brought by the FIAS Member Federations

Mr. V. Shestakov announced that there were no items brought by the FIAS Member Federations.

XIII. Items brought by the FIAS Executive Committee

Speaker: Mr. V. Shestakov

Mr. Shestakov announced that according to Decision of FIAS Executive Committee from October, 3, 2025 and according to the last changes to the FIAS Statutes Mr. Roberto Ferraris and Mr. Vladimir Yaprincev were nominated to the position of FIAS Executive Committee Honorary Members.

Mr. V. Shestakov proposed the motion for Mr. Ferraris and Mr. Yaprincev to be elected as a FIAS Executive Committee Honorary Members.

Voting: 75 Members Voted for the Motion, 1 against.

Resolved that the Motion be adopted.

XIV. Date and place of the 2026 FIAS Annual Congress

Speaker: Mr. V. Shestakov

Mr. V. Shestakov proposed a motion that the Members present to vote to hold the next FIAS Congress in November 2026 in the city of Samarkand (Uzbekistan) on the first day of the World SAMBO Championship 2026.

Voting: 79 Members Voted for the Motion, 1 against.

Resolved that the Motion be adopted.

XV. Miscellaneous

Speaker: Mr. V. Shestakov, A. Akibaev

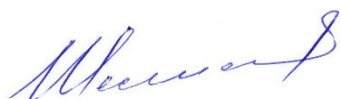
